

    - Looking at a house tour for the summer if possible, roughly 10 collegiates in attendance
      - Claudia Miraldi will work on getting a tour for the collegiate members
    - What would the cost of occupying the house be
      - Claudia Miraldi says that Control Corporation would need at least 18 people, up to 30, but does not have a price decided yet but would likely be in line with the dorms pricing

Stronger guidelines have been put in place in terms of what they are looking for
