 - Thanksgiving dinner potluck
 - Storage locker clean up/reorganization
 - Logging things
 - Preparing for moving
 - Difficult to unlock padlock on storage locker
 - Can be replaced with new lock
 - Spreading the word about convention
 - Students are not interested in attending because of cost
 - Planning to have Adam as delegate
 - Cannot receive outside funding from university
 - Shared Anthem cover competition with chapter
 - Elections coming up next week
 - Kendall is running for president again
 - Thank you for your help with the house! You're doing a great job!
- Collegiate Grounds Manager
 - Not present
- Control Corp
 - Waiting to see where we're at with leases
 - Interest seemed to have declined by the time that the lease was received
 - A lot of the people interested in living in are new initiates
 - Some people were worried that if we didn't hit the numbers, they would not be able to live in
 - We've heard back from most of the people that received the lease
 - Discuss with chapter about making living in a requirement
 - Need to see what happens next fall with lease signing, this year is a trial run

- Hoping next year will be more promising with the students using the house
- Would have to make a game plan for the future of the house if we don't do well next year
 - Fundraising
 - 100 year anniversary party is coming up
- Greg is working on the annual inspections
 - Will the students be able to use the house next semester?
 - Need to double check that certified housing is okay with them using the house
 - Reached out to certified housing about being recertified
 - For the purpose of recruitment, etc
- Sending some updates to ACC about the numbers, etc
- Security deposit
 - \$500 due before winter break
 - Venmo info, and PO box for physical check
- Assigning rooms after break
- Alarm code
 - All of ACC has it now
- Are we still planning on moving the storage lockers to the house?
 - Spend full weekend on campus
 - Moving on January 25, 2026, morning/early afternoon
 - See if the chapter can help
 - Encourage students to bring cars to the storage units
 - We have 3 storage lockers
 - Inventory
 - Share with Chris
 - Putting furniture in logical locations
 - Chapter and AA will continue to make storage payments, but to ACC to go towards costs of operating the house
