 - You can step into the position soon
 - We need a present Treasurer
- GreekTrack national dues payments
 - The payment servicer changed
 - Automatic payments may have been stopped, if were set up with the other payment servicer
 - Will include in the newsletter

 - Please apply
 - Many scholarships did not have nominations last year
 - Chapter is applying for the philanthropy award
