- Newsletters
 - Consistently published quarterly
 - Fully up to date mailing list
 - In the past year, newsletters opened has been between 51.7%
 (202) & 55.1% (217)
 - These numbers are up significantly from previous years
 - Currently received by 401 emails
 - 40% of people consistently open our emails, 14% sometimes, 43% rarely
 - Highest percentage of opens are in Chicago, Champaign and Dallas
 - Gives us a better idea of where our alum are located
- Website
 - Consistently updated throughout the year
 - Meeting notes are posted to the monthly meeting page in a timely manner
 - Dues page is updated as needed
 - New pages were created for:
 - Events
 - Shares what events are on our calendar
 - New alumni
 - Shares information on how to stay involved with APX after graduation
- Data organization
 - Consolidating our many alumni database spreadsheets into one location to access information more easily

 - Posting more often

President - Taylor Lutz

- The alumni association is stable
- The alumni association shifted their efforts in a new direction over the past year
 - It was a goal in the past to increase involvement of alumni within the alumni association

 - Due to lack of success, the focus shifted to strengthening our relationship with the active chapter
 - Hosting student oriented events

 - We currently have no active communication

Director Reports

- Worthy Architect and Pledge trainer Macy Sharp & Livi Barr
 - Overall retention rate of collegiate brothers has improved
 - More events and engagement within chapter
 - Recruitment begins next week
- Control Corp Chris Enck
 - Annual meeting being scheduled shortly
 - Recent projects
 - Chimney in lounge has been worked on
 - Other chimney's to be worked on in the future
 - Redid the landing at the side entry
 - Needed new foundation due to deterioration



- Installed central air to third floor, small window units to each room on second floor, upgraded the electrical
- Updating dormers in future
- Tuckpointing around the building is a future project.
- Organization
 - Looking for a solution for property management assistance
- The annex has been empty for the past few years
 - Funds have gone down due to this
 - Collegiate chapter will be moving in for the next school year
 - Will increase income for work on both buildings by having tenants
- Insurance policy
 - Was terminated with 30 days notice
 - Only one provider in the country will insure greek organizations
 - Cost is 60% higher than previous insurance
- Working towards a better relationship between the 3 entities of our organization
- Sourcing furniture and other things for furnishing house and annex
 - Will be minimal cost to our organizations
- Will be working on projects for getting the collegiate chapter back into the house

Old business

- The Chapter House
 - Six collegiate brothers will be moving into the annex in the fall for the upcoming school year
 - We have discussed doing fundraising for furniture that could eventually be used in the house upon moving back in
 - The alumni association and collegiate chapter toured the house with the collegiates for the first time this past July

 - Job for alumni
 - Passing of knowledge
 - Knowledge database
 - Course material
 - Alumni mentors can serve for 1 term or more
 - Add materials to the database
 - Bring in a successor
 - Mentees bring in other mentees
 - Organized by the WGAA

 - Pairing with their home chapter
 - More inclined to pair up with Anthemios brothers due to shared experience
 - Collegiates are interested in partaking in this sort of program
 - Would like to hear from our alumni about their careers
 - GreekTrack has capabilities that we can implement and use
 - Can maybe integrate into the national database
 - Why limit the term?
 - Terms would be self-established
 - Who are mentors serving?
 - Audience is open to whoever adopts the program
 - Have seen many mentorship programs start and fail
 - What will make this one succeed?
 - What are we modeling ours off of?
 - There are 3 people who have successfully done his mentorship program
 - Two colleagues
 - Mary Baum brother
 - Feedback on what to submit to the convention
 - Appoint a director to lead and manage the program
 - Meet with WGAA to go through everything before convention
 - Explore resources and budget
 - Is there support for this?
 - Support for the idea, but needs to be sorted out ahead of convention.
 - What is the end user?
 - They can save and apply the information

- Convention status

 - Around 150 people attended last year
 - Redeveloping the current program
 - Most students have never attended before
 - Working to increase interest
 - Recent conventions:
 - 2020: canceled
 - 2021: online
 - 2022: canceled
 - Was planned to be in LA, but moved to virtual due to very low registration numbers
 - Lowest number of delegates on record
 - 2023: Nashville
 - Collegiates went to convention for the first time
 - Very simple, bare minimum event
 - Many collegiates attended and it went really well
 - 2024: Omaha
 - Registration opened very early
 - 60 already registered
 - More traditional convention
 - Renegotiated the contract to try the hotel version again
 - Restructured everything
 - Registration cost went down
 - Hotels are expensive
 - Fundraising opportunity
 - T-shirts
